

**3.7.1** The institution employs competent faculty members qualified to accomplish the mission and goals of the institution. When determining acceptable qualifications of its faculty, an institution gives primary consideration to the highest earned degree in the discipline. The institution also considers competence, effectiveness, and capacity, including, as appropriate, undergraduate and graduate degrees, related work experiences in the field, professional licensure and certifications, honors and awards, continuous documented excellence in teaching, or other demonstrated competencies and achievements that contribute to effective teaching and student learning outcomes. For all cases, the institution is responsible for justifying and documenting the qualifications of its faculty. **(Faculty competence)**

USC Columbia has published criteria for the appointment of tenure-track faculty that includes a required terminal degree appropriate to the field of teaching and research or scholarship. Also, the University evaluates relevant background experience during the hiring of tenure-track or senior faculty who may be tenured at appointment. Additionally, the University reviews transcripts and conducts criminal background checks on all faculty candidates for hire. Regarding faculty hired at the four regional campuses (Lancaster, Salkehatchie, Sumter and Union), requirements include a minimum of a master's degree and 18 credit hours of coursework relevant to teaching assignments.

The Off-Site Review Committee reviewed the supporting documentation provided by USC in a Faculty Roster describing courses taught, credentials (academic degrees), and/or clarification (specialized expertise, additional educational preparation, or professional experience). The Faculty Roster, however, was found to be incomplete. In some cases courses taught were absent. In other cases the academic degrees of the faculty member were absent making comparison of courses taught to expertise impossible. The Committee was unable to determine the academic qualifications of over 60 faculty members which were listed in the attached Request for Justifying and Documenting Qualifications of Faculty.

The Off-Site Review Committee listed more than sixty faculty requiring further documentation including a limited few initially viewed as unacceptable. Based on the additional information included with the Focused Report, approximately ninety percent of these faculty were deemed qualified before the On-Site Review Committee visit. During the On-Site visit, additional information was provided allowing confirmation that the remaining faculty were found to have adequate credentials. However, during the regional campus visit, there were no resumes for part-time faculty, and several full-time faculty members were found to be not acceptable for their teaching assignments.
